

MORGAN COUNTY

Morgan County is situated in the northeastern corner of Colorado. The South Platte River bisects the county from east to west and it is the river and its valley that have dominated the history and the economy of Morgan County. Morgan County has a square shape, 36 miles by 36 miles. The county is bounded at the northeast corner by Logan County, on the east by Washington County, on the south by Washington and Adams Counties, and by Weld County on the west and north.

The valley of the South Platte River was one of the major access routes into what is now the State of Colorado. It provided a reasonably level route for wagons to travel, the river was a source of water and there was wood for fires and grass for the livestock. Several of the early western exploration parties followed the river and the 1842 expedition of John C. Fremont even left a name - Fremonts Orchard - that was applied to one of Fremont's campsites.

The 1858 discovery of gold in the mountains of Colorado set the scene for the 1859 Gold Rush. Many of the gold-seekers followed the South Platte River west to the Rocky Mountains. From Denver the South Platte River flows northward to a point near Greeley. At Greeley the river turns eastward and curves slightly to the southeast before turning northeastward at Fort Morgan and finally leaving the state at Julesburg in the extreme northeastern corner of the state.

Initially, travel followed the course of the river from Julesburg to Denver but the emigrants were always seeking a faster and shorter road. A shortcut was soon established from a point near present day Fort Morgan to Denver. This became known as the Fort Morgan Cut-off. The new road saved many miles and several days of travel. It did have a disadvantage of not following a principal stream and crossed a dry, often sandy terrain, that made travel more difficult than the path along the South Platte River.

The completion of the Union Pacific Railroad to Cheyenne, Wyoming and beyond, in the late 1860's greatly reduced travel along the South Platte. However, in 1881 traffic returned to the route with the construction by the Union Pacific and its subsidiaries of a railroad direct to Denver. That road passed through Morgan County in 1881. The next year, 1882, the Burlington Railroad came into the county directly from the east to Brush and to the vicinity of Fort Morgan where it then followed the old cut-off route on to Denver. Later the Burlington would construct a connection from Brush to the Union Pacific at Pawnee and make use of Union Pacific tracks from Pawnee to Sterling, where a branch line would continue north to Sidney and Alliance in Nebraska and on to Billings, Montana.

In the twentieth century, automobile traffic developed rapidly and the South Platte Valley once again became a major route for traffic to Denver. US Highway 6 paralleled the Union Pacific from Sterling to Fort Morgan and then followed the Burlington Railroad the remainder of the way to Denver. US Highway 34 joined US 6 from Brush west to Wiggins.

In the late twentieth century, Interstate 76 was constructed from Denver to Julesburg as a diagonal connection between Interstates 70 and 80. Although I-76 follows US 6 and the old Fort Morgan Cut-off from Denver to Brush, I-76 remains on the south side of the river until it joins I-80 in Nebraska.

Away from the river, travel is on a network of county roads. Colorado Highway 71 does cut the county from north to south, passing through Brush and there are short segments of State Highways 39, 52 and 144 within Morgan County. The county road system is typical of most eastern Colorado counties. Numbered roads, north-south, begin on the west edge of the county and increase to the east. The east-west roads begin with the letter A on the south edge of the county and increase to the north. As usual, there is no Road I or Road O, and the next road north of Road Z is Road AA and so on to the northern county line. Most of the county roads are well maintained but some can become very muddy after a heavy rain.

Drainage of the county is either north or south to the South Platte River. From the south, Kiowa Creek, Bijou Creek, Sand Arroyo, Badger Creek and Beaver Creek flow north to the South Platte. From the north, Cottonwood Creek and Wildcat Creek are the most important streams.

The early roads along the South Platte were the location of several early stage stations; however, the stage stations left no permanent settlements. In 1864 during the height of the Indian troubles, a military post was established at what is now Fort Morgan. By 1868 the post was no longer needed and it was closed.


The early travelers recognized that the South Platte Valley was fertile farmland and agriculture soon developed along the river. A network of irrigation canals was constructed to provide water to the farms during the dry summer months. To the north and south of the river, the higher and drier terrain was more suited to ranching and large cattle and sheep ranches quickly developed. In the twentieth century, the drilling of deep wells provided water for irrigation and grain production spread into those areas.

Since the days of the early travelers agriculture has played the most important role in the economy of Morgan County. To a large extent the modern economy of Morgan County still depends on agriculture but also on a number of small businesses in Fort Morgan and Brush, and traffic along Interstate 76.

Politically, the area that is now Morgan County was initially within the original boundaries of Weld County. Morgan County was severed from Weld County on February 19, 1889 and Fort Morgan was selected to be the county seat. Most of the towns and post offices in Morgan County have been located in the South Platte River Valley and along the railroads. The few post offices away from the river were either short lived or served larger communities of scattered ranches and farms rather than organized towns.

ADENA

The first residents in this vicinity came mostly from Illinois and Nebraska. The area was, and still is, one of scattered ranches with some farming. It is doubtful that there was a central community. Adena would be best classified as a "ranch post office."

The story is that the name was that of the sweetheart, Edna Adena, of one of the settlers. One reference indicates that Sand Arroyo was another name proposed for the post office. Other than these few facts, nothing more has been written about Adena.

From Fort Morgan drive south on Morgan County Road 19 to County Road F. Turn west on Road F to County Road 14, then turn south on Road 14. The 1914 and later sites of Adena were just north of the Morgan-Adams County line. In 1996 on the east side of Road 14 there were still a couple of buildings, including the abandoned Sand Arroyo 4-H Club and the Adena Town Club building. A side trip is necessary to visit the first site of Adena (1910). After making the turn south on County Road 14, go two miles then turn west on County Road D. Go one mile then turn south on County Road 13. A halfmile from the turn you will be at a ranch with a modern trailer and some older barns. You will have to backtrack to Roads D and 14 as the ranch and the site are at the end of the road.



ANTELOPE SPRINGS

Antelope Springs was an early twentieth century ranch post office about eight miles north of Snyder. The name is a reference to the nearby Antelope Creek and the animal called pronghorn antelope, *Antilocapra americana*.

The Post Office Department Geographic Site Location Reports provide two locations for the Antelope Springs Post Office. The first site (1911) is a mile west of Colorado Highway 71 in the southeast quarter of the intersection of Morgan County Roads 28 and GG. The second site (1914) is on the east side of Highway 71, one mile north of County Road GG. Nothing remains at the older site but there are active ranch buildings at the 1914 site.

Antelope Springs was not an organized community but there was a school and a few ranches in the vicinity.

Starting at the point in Snyder where Highway 71 turns due north, it is about nine and one-half miles north to the intersection with County Road GG.

BIJOU VIEW/BIJOUVIEW

Bijou View was another of the remote ranch post offices in the southern portion of Morgan County. There was no organized community at the site.

The name is most likely a reference to Bijou Creek, which crosses County Road F about two miles west of the site of Bijou View. Another story for the name claims that it is a corruption of the name of Joseph *Bijeau* a French guide who is said to have accompanied the Stephen H. Long expedition in 1820. Perhaps that version is more appropriately applied to the naming of the creek and thus eventually the post office.

After visiting the sites of Adena, return to Morgan County Road F and turn west. Bijou View was in the northwest corner of the intersection of County Roads F and 10. This is four miles west of Road 13 and nine miles west of County Road 19, the road south from Fort Morgan. Road 10 to the south, is now (1996) the entrance to the Thomas Ranch. There is nothing remaining at the site of Bijou View, however the faint track of an old wagon road does go northwest cross-country from the intersection.

BRUSH

In May 1882 A. B. Smith, working for the Lincoln Land Company, surveyed a townsite which was named Brush for Jared L. Brush. Jared Brush was one of the early cattlemen in northeastern Colorado who ranged cattle in the territory south of the South Platte River from Julesburg to Greeley. In 1894 and again in 1896 Jared Brush was elected Lieutenant Governor of Colorado.

Early settlements at this location went by the name of Beaver Creek. The town plat was filed June 4, 1881 and Brush was incorporated in 1884.

The site of Brush was on the route of the Burlington Railroad that was building west from Kansas into Colorado on the way to Denver. Founded at about the same time as Fort Morgan, ten miles to the west, the two towns were rivals to become the commercial center of Morgan County. When Morgan County was created, Fort Morgan was named the county seat, assuring its preeminence in the county. However, Brush did not fade away as did so many of the early railroad towns. Brush remains a sizeable town with an active business district and a number of commercial establishments serving the surrounding ranches and farms.

In 1906 the Great Western Sugar Company built a sugar beet processing plant at Brush and for many years that was a major contributor to the town's economy.

Brush was also the junction point for the Burlington main line with a branch railroad that went northward to Sidney, Nebraska and eventually to Billings, Montana.

Brush is located on the south side of Interstate 76 between Exits 90 and 92. Exit 92 also provides direct access to Colorado Highway 71, which is the road south to Gary or north to Snyder, Hillrose, Pawnee and Antelope Springs.



CORONA

The early history of Corona is somewhat inprecise. The name was first applied to what was originally the Green City Colony that was located in present day Weld County. The change in name took place when the Colony was reorganized in 1871 or 1872.

The Post Office Department Geographical Site Location Reports indicate that in 1874 the post office was "moved" from Green City and became Corona. However there is no specific location for the post office at that time. By 1883 the Corona Post Office was specifically located in Morgan County on the Burlington Railroad about eight miles southeast of the old Green City location. It is possible that the Corona Post Office remained at Green City until construction of the railroad.

With a more advantageous location on the railroad, Corona did develop into a small commercial community.

The confusion in the history of Corona does not end with the move to the railroad. The community was platted in 1888. At some subsequent time one Oliver P. Wiggins enters the picture. He was a Canadian by birth and claimed to have been a scout with at least one of the Fremont expeditions. That claim and many of his other stories are considered tall tales. However, he apparently was of sufficient notoriety and respect that in the mid-1890's the community was renamed Wiggins in his honor. The change in the post office name took place in December 1896 and not in the early twentieth century as reported by some writers.



CORONA, / COLO.

Corona, now Wiggins, is on the south side of Interstate 76 at Exit 66, four miles east of the Morgan-Weld County line.

There is more confusion with the post office names in this area along the modern Interstate 76. There are claims that Corona/Wiggins began life as Vallery. Also, for a brief period in 1882-1883, there was a Cotsworth Post Office in the area. Cotsworth may have been closely associated with the Corona community but more likely was some four miles east of Corona/Wiggins. Please refer to the discussions of Cotsworth, Vallery and Wiggins for more comments on this rather confusing situation.

COTSWORTH

Cotsworth has received only a brief mention in the historical literature of Colorado. It is simply described as, "a railroad post office eleven miles west of Fort Morgan." That estimate of distance would place it about four miles east of present day Wiggins and south of Interstate 76.

At the approximate location there is a small ranch or farm complex just south of the railroad. I stopped on I-76 and walked up to the railroad to take photographs of these buildings. It should be possible to get to the site by exiting Interstate 76 at Exit 73 (Long Bridge Road). Go south one mile to Road S and turn west three miles to Road 8 and then north to the railroad. The buildings are on the west side of Road 8.

The Post Office Department Geographic Site Location Report, mentioned below, supports this location and perhaps indicates that there was an intention to re-establish the Corona Post Office at this place. That did not happen. The Corona Post Office did reopen, little more than a month after the Cotsworth Post Office was established.

The short life of the Cotsworth Post Office indicates that it could not compete with Corona, only four miles to the west. Although at first there might have been plans to establish the Corona Railroad Station at this site, apparently that did not happen and without the railroad station there was nothing to support the development of a community.

The community name was the family name of the one and only postmaster – Arthur L. Cotsworth.

DEUEL

In 1883 the Morgan Post Office was closed and the Deuel Post Office was opened. This involved a move of the office about two miles further west along the Union Pacific Railroad.

On April 5, 1886 Lafayette More filed a town plat for Deuel. Lafayette More was the one and only postmaster at Morgan but did not continue as postmaster when that office was closed and moved. Today, this area west of Colorado Highway 52 is mostly farmland with some scattered residences.

By 1890 the wandering post office and the community name had moved again, this time to a location between the Union Pacific Railroad and the South Platte River some eight miles to the northwest of the original location. In 1907 the post office would move once more, a half-mile north to a location on what is now Colorado Highway 144 and would change its name to Weldona.

I have been unable to find any information that would explain the source of the name Deuel.

To reach the second location of Deuel, begin at Exit 79 on Interstate 76 - the exit for Log Lane Village and Colorado Highway 144. Drive northwest on Highway 144 ten miles to Weldona. At Weldona turn south on MorganCounty Road 9. According to the Geographic Site Location Report, Deuel was located to the east of Road 9 and on the north side of the South Platte River. This area is open farmland with a few farm buildings near the river.





DODD

Two sources refer to Dodd as, "A railroad post office about eight or nine miles northeast of Fort Morgan on the Union Pacific Railroad." This description does not agree with the information that I have at hand

The 1973 General Highway Map of Morgan County locates Dodd as a Union Pacific siding approximately five miles east of Colorado Highway 52. That location is in Section 25, Township 4 North, Range 57 West. The location given in the Post Office Department Geographical Site Location Report is in Section 31, some five miles to the west in the same township and range but still on the railroad. That location is in the half-mile between the original location of Morgan and Highway 52.

Given the proximity of the described location to Fort Morgan, placing the Dodd Post Office at Dodd siding seems more logical but stranger things have happened.

The location near Highway 52 is described in the discussion of Morgan later in this chapter. To reach the other site drive about one mile north from the South Platte River bridge on Colorado Highway 52 to Morgan County Road T.5. Turn east. It is about five miles to Dodd Siding which is located between County Roads 23 and 24. There are active farms in the area but the siding has been removed. The grade is still visible.



DUBLIN BAY

I have been unable to find any reference to Dublin Bay other than what is reported in the Post Office Department records. Even those records are not clear as to the status of this "post office."

There is a Geographic Site Location Report for the proposed Dublin Bay Post Office so it can be determined where Dublin Bay was to be located. There is also a record of the appointment of a postmaster and supposedly the establishment of the office concurrent with his appointment. From then on the records are silent. There are no further entries of subsequent postmasters or a date on which the office

DUBLIN BAY – Continued

was either discontinued or the establishment rescinded. No postmarks have been reported from Dublin Bay, therefore I suspect that the post office was never in operation.

The choice of the name Dublin Bay is an odd choice for a location in the extreme northwestern corner of Morgan County. The Site Location Report indicated a preference for the name Laverne but that was rejected by the Post Office Department.

Starting at Colorado Highway 144 in Orchard drive a very short distance north to Morgan County Road X. Turn east a short distance to County Road 2 and then head north. The payement soon ends but the road continues. I made this trip in May of 1996. At a point some nine miles north of County Road X, Road 2 came down a low hill and disappeared into a lake. There was an unimproved dirt track to the west that curved around the end of the lake and rejoined Road 2 on the north side of the lake. Another mile and a half-mile north of County Road HH I found two small, lonely, abandoned buildings, near the southern edge of the quarter section described for the location of Dublin Bay. Other than those buildings, the road and a power line along the road there was nothing else visible in any direction. Lots of wide-open, lonesome ranchland.

Maps indicate that one might be able to continue north, eventually intersecting Colorado Highway 14 between Briggsdale and Buckingham in Weld County. After taking pictures I chose the known road and returned to Orchard.

FORT MORGAN

The site that would eventually become Fort Morgan began as a campground for travelers on the Platte River Trail to Denver. The location was also near the place where the trail divided. One branch followed the South Platte River westerly towards the mountains with access to the gold mines through Boulder.

The other branch of the trail ran southwesterly to rejoin the South Platte at Denver, avoiding the longer arc that the river took. This became known as the Fort Morgan Cut-off. Although it was considerably shorter, it was also dryer and plagued with stretches of soft sand.

In 1864, in order to protect travelers and the U.S. Mails from Indian depredations, a military post was established at the old camp ground and given the name of Camp Tyler. In 1865 the post was renamed Fort Wardell. Historians seem confused about the correct spelling for this Fort. Almost equal numbers choosing Wardell as those choosing to spell it Wardwell. There was no official U. S. post office at either the camp or the fort but one cover does exist with a manuscript docketing "Camp Wardell / Junction Colo."

On June 23, 1866 the spelling was resolved when the name of the military post was again changed, to Fort Morgan, in honor of Colonel Christopher A. Morgan, a prominent Union officer who died on January 20, 1866.

FORT MORGAN – Continued

One more time history becomes confusing. Colonel Morgan has been reported as the first commanding office at Fort Morgan but most writers state that Colonel Morgan was never west of Saint Louis.

With the completion of the Union Pacific Railroad to Cheyenne, Wyoming there was a significant decline in traffic along the South Platte River and hence the need for military protection. On May 18, 1868 Fort Morgan was abandoned. The fort was occasionally occupied but sheepmen and cattlemen slowly dismantled the buildings for the timber that was otherwise in short supply.

In 1881 the Union Pacific Railroad built along the north side of the South Platte River. A year later the Burlington Railroad built along the south side of the river and thus the location of the old Fort Morgan was between the two railroads. A new community began to develop and on May 1, 1884 Abner and Sarah Baker filed a plat for the town of Fort Morgan.

There had been a post office at the military Fort Morgan but it was discontinued a few weeks after the fort was closed. On May 28, 1884 Fort Morgan once again acquired a post office. The growing town was incorporated in 1887. On February 19, 1889 the Colorado Legislature authorized the creation of Morgan County from the southeastern corner of Weld County, the final reduction of Weld County. Fort Morgan was chosen to be the county seat for the new county.

With its location on two railroads and on the South Platte River, Fort Morgan quickly developed into a major agricultural and commercial center for a large area between Denver and Sterling. It continues to enjoy that status to the present day.

Access to Fort Morgan is from Interstate 76 at either Exit 79 or Exit 80.



During the transcription of data from the microfilmed Post Office Department Geographic Site Location Reports, the note, reported below under the chronology of the post office was discovered. It was a puzzle; as until that time I had not found mention of any type of Branch Post Office at Fort Morgan. I called Jim Ozment who is greatly interested in the Colorado Post Office Stations and Branches. He too had never heard of any such facility at Fort Morgan.

A few days after my phone call Jim was having lunch with some of his friends, one of whom had been in the army during World War II. Jim asked the question if any one had ever heard of a Glider Training Facility at Fort Morgan. The army veteran answered, "Yes. I was stationed there!"

Okay, so now we had confirmation that the facility did indeed exist but did it have a post office? Several months later Jim went through Fort Morgan and went to the address mentioned in the note below. While standing there pondering the situation, an elderly lady came walking by. Jim, at times not bashful, stopped her and asked if she had lived in the area for any length of time. She replied, "Yes." Next question, did she remember the Glider Training Facility? Answer, again "Yes." The big question: did she recall if they had a post office and where was it? Her answer: "In the vacant lot on the other side of the street."

Now we knew there was such a facility and they had some sort of a post office but did they process mail?

About a year later I was at a stamp show and going through a box of rather common covers when I found a nice World War II Patriotic Cover with a very clear August 1, 1942 Fort Morgan, Colo. machine postmark. For, if I recall correctly, \$3.00, I thought it worth taking home. Then I turned the cover over and discovered a penciled note on the reverse: "Carried by K. Stuhlduher on ferry trip of planes." It seems likely that Mr. Stuhlduher was a collector and was involved with bringing planes into the Glider Training Facility.

There is no postmark evidence on the cover to prove that it passed through the post office at the facility and to date no postmarks have been reported. My supposition is that the facility post office did not normally cancel mail but mail was received and taken the few blocks to the main Fort Morgan Post Office for postmarking and dispatch. The post office at the facility was most likely concerned with financial transactions, money orders to and from the base personnel.

There may be Fort Morgan Glider Training Facility postmarks yet to be found, so keep your eyes open.

FREMONTS ORCHARD

In 1842 the expedition led by John C. Fremont camped in an extensive grove of cottonwood trees where Kiowa Creek from the south enters the South Platte River. The location came to be known as "Fremonts Orchard" because the cottonwoods resembled an old fruit orchard. With the start of the 1859 gold rush to Colorado, the principal route of travel for immigrants and freight wagons was along the southern side of the South Platte River. A stage station was built at Fremonts Orchard and a post office briefly operated there in 1863-1864.

In 1874 another post office with the name of Fremonts Orchard opened. The re-establishment may or may not have been at the same location as the earlier office but was certainly nearby. This time the post office lasted almost three years but it soon closed as travel west from the area of old Fort Morgan gradually shifted to the north side of the South Platte River.

To reach the 1874 location specified for Fremonts Orchard, drive south from Goodrich on Colorado Highway 39. After crossing the South Platte River the highway angles to the southeast for about a half-mile. In that short stretch of the highway and before the highway rises out of the valley, there is an unimproved road to the west. In 1996 I was able to drive a mile west on that road before coming to a locked gate. The plotted location for Fremonts Orchard was a half-mile further west, but from the gate I could not see any buildings or other evidence of a settlement.

It is likely that the 1874 version of Fremonts Orchard was no more than a ranch post office.

Gary was a rural post office located twelve miles south of Brush and to the east of Colorado Highway 71. The location is in the farmland and cattle range countryside of southeastern Morgan County. There is no evidence that there was any sort of an organized community at the location.


To visit these sites, from Brush drive south on Colorado Highway 71 to Morgan County Road F. The reported 1937 site of Gary was in the southeast corner of the intersection of the two roads. There is an active ranch complex at that location.

The first site of Gary, 1889, was one mile to the east of the intersection of Highway 71 and Road F, in the southeast corner of the intersection of County Roads F and 30. There are buildings at this location but they appear to be of fairly recent construction.

To reach the second, 1935 site of Gary, continue west on Road F one mile to Road 31 and turn north. In one mile Road 31 intersects Road G where you are forced to turn. A short distance west of that intersection there is another active ranch complex continuing some older buildings. After visiting the third site, continue back to the west to Highway 71.

In 1996 when I visited the three sites they all appeared to be inhabited, active ranches.



GOODRICH

The settlement of Goodrich began in 1882 shortly after the Union Pacific Railroad built west along the South Platte River. Goodrich was another of the small agriculture based communities that developed along the river and the railroad. The settlement was named for a Mr. G. T. Goodrich, a pioneer settler in the area and a member of the first board of County Commissioners for Morgan County.

Although the community originates in 1882 it was not until July 20, 1911 that the town was platted by Warner Coontz, president of the Riverside Lumber Company.

There is still a small community some five miles west of Weldona. Follow Colorado Highway 144 west from Weldona to the intersection with Colorado Highway 52, turn south on Highway 52 and immediately into what remains of Goodrich. There are a few remaining homes and some business buildings that may or may not still be in use.



HILLROSE

Hillrose is a farming community that was established by the Lincoln Land Company, the townsite corporation acting on behalf of the Burlington Railroad. It is located on the Burlington branch that ran from Billings, Montana to the main Burlington line at Brush. The townsite was surveyed May 17, 1900 by A. B. Smith. The town plat was filed on October 8 of the same year.

Mrs. Kate Emerson deeded the land to the railroad and was permitted to select the name for the new community. She chose to use her sister's name, Rose Hill, but reversed and combined the names to create Hillrose.

Hillrose continues to exist as a small residential and commercial community about six miles northwest of Brush on the railroad and on US Highway 6. To reach the site from the point on the east side of Brush where Colorado Highway 71 turns south, continue east and northeast on US 6 some five miles to the diagonal intersection with Morgan County Road W. From there turn east into Hillrose.



HOYT

About 1882, Mrs. Sidney Davis Hoyt with her two sons Edwin G. and Dr. James A. Hoyt took a homestead just north of the Morgan-Adams County line in the extreme southwestern corner of Morgan County. A small but scattered community developed.

Dr. James A. Hoyt was, in addition to being a doctor, also a surveyor who did work for the railroads. The town was named for him and the Hoyt family.

In 1976 there was still a small combination general store and post office at Hoyt. The post office was closed in 1991 and perhaps also the store. When I again visited the site in 1993 the store was no longer open.

From US Highway 6 one mile east of Wiggins, drive south on Colorado Highway 52. Two miles south of Morgan County Road F the highway turns west for one mile then once again south. From that turn it is two and one-half miles to Hoyt. Just before you reach the community there is a slight jog in the road. The old store and post office was on the east side of the highway immediately north of the county line.



JUNCTION HOUSE

The Junction House Post Office presents several possible locations and it is difficult to decide exactly where this post office was located.

An excellent reference for the early history of the South Platte Valley is the *Historic Trail Maps of the Sterling 1 x 2 Quadrangle, Northeastern Colorado* prepared by Glenn R. Scott and published by the United States Geological Survey. This particular map shows three possible locations in the strip from Merino to Fort Morgan. All are on the south side of the South Platte River.

The easternmost is in Washington County about two miles south of Merino and on the east side of US Highway 6. The second is in Morgan County, approximately three miles northwest of Brush. Both of these locations are labeled "Junction House".

The third possible location is just north of present day Fort Morgan but is labeled "Junction Ranche."

The Post Office Department Geographic Site Location Report is too indefinite in its description to be of any real help. The Post Office Department records indicate that when it closed the Junction House Post Office was moved to Fort Morgan. That does seem to be correct but it does not necessarily support a choice of the Junction Ranche site near present day Fort Morgan as the site of the Junction House Post Office. In the 1860's post offices could be, and were, moved several miles when settlement patterns changed.

In Colorado Historical literature I found three mentions of Junction House. Two of those references place Junction House *about four miles northeast* of Brush.

Junction House is described as a stage station on the Overland Route to Latham. From the name it would seem that it was associated with the junction of the main trail along the South Platte River and the cut-off trail to Denver. At first the Fort Morgan Cut-off did begin at a point north of Brush. At some point, probably around the time the military post (Camp Tyler) was established, the junction of the trails moved to the vicinity of the military post. Camp Tyler was established in 1864 which fits with the opening of the Junction House Post Office.

Trying to make sense of this is difficult. I first thought the post office was at the site north of Brush and perhaps it was there briefly. It now seems more reasonable to locate it at what Glenn Scott refers to as "Junction Ranche," in the area north of Fort Morgan and slightly east of modern Colorado Highway 52 before that road crosses the South Platte River.

The site near Brush is not accessible by road but from a distance there does not seem to be any remnant structures.

The site near Fort Morgan is now part of the city of Fort Morgan and urban sprawl and the construction of Interstate 76 have replaced any older buildings.

More study is needed to resolve the questions relative to the location of the Junction House Post Office.

One reference reports that Morgan was shown on 1887 maps of Colorado and that it may have been the same site as Deuel. No other information is available. The Morgan Post Office came into existence in late 1879 and continued to operate until 1883. I believe it was established in anticipation of the railroad that was planned for construction along the north side of the South Platte River. Morgan lasted beyond the arrival of the Union Pacific's railroad but when the Burlington Railroad was built through the area on the south side of the river the commercial focus shifted to the new Fort Morgan, south of the river.

There would also have been potential confusion within the Post Office Department between the names Morgan and Fort Morgan, particularly when these places were so close together. In February 1883 the Morgan Post Office closed and was moved about a mile and half to the west taking a new name - Deuel. By 1890 the Deuel Post Office had been moved six miles to the northwest.

The location from the Post Office Department Geographic Site Location Reports is opposite Fort Morgan and on the north side of the South Platte River. From Interstate 76 Exit 80, go north on Colorado Highway 52 across the river to the railroad. There is still a small railroad yard east of Highway 52 withsome warehouses and a feed plant. The Morgan Post Office was somewhere within that small industrial complex, approximately a half mile east of the highway. No buildings of the period remain.

ORCHARD

The Orchard Post Office was established in 1882, shortly after the Union Pacific Railroad built through the area. However, the town was not surveyed and platted until March 7, 1890 when George M. West and P. W. Putnam laid out the townsite. The townsite, on the north side of the South Platte River, is about five miles west of a grove of stunted cottonwood trees that came to be known as Fremonts Orchard because the grove was a campsite during John C. Fremont's 1842 expedition. The shortened name perpetuates the original name.

In 1881 there was a railroad station and about twenty settlers, mostly stock raisers. By 1906 Orchard was described as having "a railroad station, post office, a general merchandise store, a hotel, and the homes of farmers and railroad people."

There have been some claims that the Orchard Post Office was a successor to the Weldon Valley Post Office that operated briefly in 1880. However, the Post Office Department Geographic Site Location Report for Weldon Valley locates that office some three miles to the east and only a short distance west of the later location of the Goodrich Post Office.

ORCHARD - Continued

There is still a small community at Orchard with a number of homes and some small agricultural and service businesses. As happened at Weldona, the post office has moved from an older, brick-fronted building (1976) to a standard design building typical of small town post offices.

From Goodrich continue west three miles on Colorado Highway 144 to Orchard.



PAWNEE

Pawnee was a railroad post office at Union Junction where the Burlington Branch, having used the Union Pacific tracks from Sterling, branched off to continue south across the South Platte River to meet the Burlington main line at Brush.

A small community did develop at the location but it never grew to any size and by 1996 only a few abandoned buildings remain to mark the site. One of the buildings still standing and seemingly in fairly decent shape, is a large two-story structure. It was likely a store and perhaps it was home to the Pawnee Post Office.

The town name is that of an Indian tribe that once inhabited the plains of Kansas and eastern Colorado. When the post office application and Geographic Site Location Report were filed three names were suggested for the post office: Union, Brooks and Pawnee. Pawnee was accepted. The railroad siding at this location is still known as Union.

To get to Pawnee, follow the directions from Brush to either Snyder or Hillrose. From Hillrose, and the intersection of Morgan County Road W with US Highway 6, drive north on County Road 33 and cross to the north side of the South Platte River to the road that parallels the Union Pacific Railroad. Turn northeast and in about a mile and a half you should encounter the previously mentioned buildings.

From Snyder, a road on the south side of the railroad goes northeast along the railroad to the buildings at Pawnee. The buildings are just east of the branch railroad to the south.

The Burlington Branch may no longer be in operation but the railroad grade should be obvious.



SNYDER

J. W. and H. D. Snyder came to Colorado to assist in the round-up and sale of cattle belonging to the estate of J. W. Iliff. For their base of operations they chose a site north of the South Platte River in what is now eastern Morgan County. A small community of cowhands developed at the camp and when the Union Pacific Railroad built along the north side of the South Platte River the settlement grew into one of the principal cattle shipping centers in the state.

In 1882 a post office was acquired and took the name Snyder in honor of the Snyder brothers. The town was unorganized until H. N. Claney and H. B. Davis filed a plat for Snyder on September 22, 1887.

In its early days Snyder was a significant commercial center but as Brush, five miles to the south grew, and grew rapidly, the importance of Snyder declined.

Snyder is still a modest sized community with a few businesses providing the local and nearby residents with some basic services. However, it has become more of a residential community than a commercial center.

From Brush or from Exits 90 or 92 on Interstate 76, drive north on Colorado Highway 71 and cross to the north side of the South Platte River. Snyder is just north of the river, on the east side of the highway. The post office is on Carson Street, just south of Edison Street.
















VALLERY

There is mention in the Colorado historical literature of a Vallery Station associated with the location of Corona/Wiggins. However, I do not believe that to be correct.

The Vallery Station on the Burlington Railroad was about five miles east of Wiggins, opposite milepost 72 on Interstate 76. On March 11, 1908 the Lincoln Land Company filed a town plat for Vallery. The town was named after John Vallery, a general freight agent for the Burlington Railroad.

A small community did develop at Vallery but all that remains in the twenty-first century are a few farms along the frontage road on the north side of Interstate 76. Apparently it could not compete with nearby Wiggins and with the much larger Fort Morgan to the east.

To reach the site, take Exit 73 (Long Bridge Road) from Interstate 76. Turn north and then go west on the frontage road on the north side of the interstate. Vallery was approximately one mile west of the exit.



WELDON VALLEY

George Crofutt described Weldon Valley thusly: "On the north side of the South Platte River, opposite Fremont's Orchard is a ranche and post office, for the accommodation of a few hundred people who are engaged in farming and stock raising. The place is on the line of the O. & D. S. L. of the Union Pacific Railway." Crofutt's guidebook was published 1881, so he was most likely describing the situation in 1880 when the Weldon Valley Post Office was in operation. "O. & D. S. L." is a reference to the Omaha, Denver & Salt Lake, apparently the early but discarded name for the railroad to be built from Julesburg to Denver.

Weldon Valley has been claimed to be a predecessor of Orchard but it is three miles east-northeast of Orchard and only a very short distance west of the site of Goodrich.

Follow the directions to Goodrich but continue west on Colorado Highway 144 from Goodrich towards Orchard. That area is now open farmland, with an occasional complex of farm buildings.

WELDONA

In 1907 the post office that began life as Morgan on the Union Pacific Railway, then moved a couple miles west to become Deuel, then moved again eight miles northwest but still on the railroad, finally found a permanent home as Weldon on what is today Colorado Highway 144.

WELDONA - Continued

The common understanding is that the town was named after a General Weldon. The area is referred to as the Weldon Valley, even though the South Platte River forms the valley in which the community is located.

Settlement in the area may have begun as early as 1866. On February 24, 1893 Prucius Putnam filed a plat for the town of Weldon. When a post office was established, the additional letter, "a," was added to Weldon, supposedly to avoid confusion with Walden in Jackson County. A postmark with the spelling Weldon is known to have been used in 1944.

From the beginning of settlement, the South Platte River has provided water to irrigate the fertile land along the river. Weldona developed as a small community providing agricultural related and other services for the surrounding area.

Colorado Highway 144, which parallels the railroad, is the main street of Weldona. There are still a few small businesses in the community and a fair number of occupied residences. My first visit to Weldona was in 1976. The post office was in a small, neat brick building on the north side of the highway. When I returned twenty years later, the brick building was still standing but the post office had moved to one of the now standard small, nondescript buildings that resemble a mobile home.

Colorado Highway 144 begins at Exit 79 from Interstate 76, just west of Fort Morgan.



WIGGINS

I assume that you have read the previous discussions of the post offices at Corona, Cotsworth and Vallery and are thus cognizant of the confusion in the names and locations of the post offices along what is now Interstate 76 in west-central Morgan County.

Several historical discussions of Wiggins make the claim that the Wiggins Post Office was not established (with that name) until the early 1900's. However the post office records are clear that the Wiggins Post Office came into existence on December 2, 1896 as a change in name from Corona.

WIGGINS – Continued

By 1896 Wiggins/Corona was an established commercial community on the Burlington Railroad, serving farmers and ranchers in western Morgan and southeastern Weld Counties. It remains so into the twenty-first century.

The community was first surveyed and platted as Corona on September 10, 1888 by Thomas J. McCartney. On May 12, 1908 Frank McCartney and Everrett Owens filed a town plat for Wiggins. By that time the name Wiggins was well established and the Wiggins Post Office had been operating for twelve years.

The name Wiggins honors one Oliver P. Wiggins. Mr. Wiggins was at best a local character, and it seems certain a teller of "tall tales." He was, it is accepted, a Canadian by birth. He claimed to have come to Colorado as a guide and scout for Captain John C. Fremont in the 1840's and to have been associated with Kit Carson. He also claimed to have worked for the Hudson Bay Company. He became known as "Old Scout" and sometime, somehow, acquired the title of "Major," titles that he likely created for himself. It is now suspected that most of his history was fabrication on his part. It is accepted that Mr. Wiggins did open a store at Corona and that the post office came to be located in his store, which probably led to the change in name to Wiggins.

Wiggins is located south of Interstate 76 (Exit 66), about four miles east of the Weld-Morgan County line. In 1996 the post office was in a small strip mall on US Highway 6, north of the railroad.
