

# ARAPAHOE COUNTY

The name of Arapahoe County has appeared on maps since even before Colorado Territory came into existence. The western portion of Kansas Territory was divided into a few counties, one of which was named Arapahoe. It is rather doubtful that there was any real administrative jurisdiction as the residents created "Jefferson Territory" in order to provide a more receptive and on the scene government for the new mining region.

That original "county" spanned Kansas Territory from north to south and from the foothills of the Front Range eastward well out on to the plains.

Arapahoe County was one of the original seventeen counties created November 1, 1861 by the Colorado Territorial Legislature. It was a narrow east-west rectangle, bounded on the north by the Fortieth Parallel and reaching eastward to the boundary with Kansas. Included in the western portion was the city of Denver, which was the county seat. That configuration continued into the twentieth century.

On April 15, 1901 a number of changes occurred that reduced Arapahoe County to its present boundaries. The eastern portion was cut off and divided between Yuma and Washington counties. The western portion became the City and County of Denver.

The remainder of the county was split along an east-west line (East Colfax Avenue and its eastward projection). The portion north of the line became Adams County. The portion south of the line was briefly called "South Arapahoe" County and Littleton was designated as the county seat.

Modern Arapahoe County is only twelve miles from north to south, but stretches east-west for seventy-two miles.

Today, Arapahoe County is bounded on the north by Adams County, on the east by Washington County and on the south by Elbert and Douglas counties. The western boundary with the City and County of Denver is highly irregular, having been dictated by the boundaries of the cities of Aurora, Englewood and Littleton.

Topographically, Arapahoe County varies from nearly level, to rolling hills typical of the Colorado prairies. Drainage is entirely northward to the South Platte River by means of numerous seasonal or intermittent streams. The more important streams are Dry, Boxelder, Kiowa, Comanche, Bijou, Deer Trail and Beaver Creeks.

Early travel in the county was confined to the South Platte Valley. In 1870 The Kansas Pacific Railroad entered the county from the south following the Bijou Creek drainage for a distance before turning west towards Denver along what is now the northern boundary of the county. That route also became a path for wagon traffic and in the twentieth century for US Highway 40 and for Interstate 70.

The Denver and Rio Grande and the Santa Fe Railroads cross the extreme western end of the county on the way from Denver south towards Colorado Springs. The Denver and New Orleans (later the Denver & Fort Worth and finally as the Colorado and Southern Railroad) ran southeastward from Denver towards Parker in Douglas County and beyond. That railroad was removed during the 1930's.

US Highway 36, for the most part, follows along the boundary with Adams County until it merges with Interstate 70 at Byers. On the western end, US Highway 85 took traffic from Denver south towards Colorado Springs. More recently, Interstate 25 has become the major arterial highway to the south.

The western portion of Arapahoe County is virtually indistinguishable from Denver and as such has an extensive network of roads and city streets. The eastern two-thirds of the county is still rural in nature and although there is a county road network, it is not as extensive as in other eastern Colorado counties.

From the early days the economy of Arapahoe County has had a dual focus. The western end was oriented towards the City of Denver, serving as residential suburbs and to some extent as a site for industry and commerce. The future of this section of the county will continue to be heavily influenced by the actions of Denver - the big brother to the north.

The eastern two-thirds of the county has been and continues to be mostly agricultural. There is some farming, but raising livestock is the principal endeavor. There were few "communities" in this area but only ones along the railroad (and subsequently US-40 and I-70) achieved any permanence. The situation is gradually changing. Metropolitan Denver and its suburbs continue a slow eastward advance. How far that will proceed will most likely be determined by the availability of water to feed suburban homes, lawns and golf courses.

# **BEAVER CREEK**

With the exception of the information from the Post Office Department records I have found no reference to a place named Beaver Creek in Arapahoe County.

Beaver Creek took its name from the nearby stream of that name. The surrounding countryside is primarily grazing land with some farming. It seems obvious that this was no more than a short-lived ranch post office. Today, this area of eastern Arapahoe County is very sparsely populated.

To observe the site, or at least the area in which the Post Office Department Geographic Site Location Report places Beaver Creek, begin in Deer Trail on Interstate 70. From Deer Trail, east of I-70, drive a short distance north to Arapahoe County Road 34 (Jolly Road) and turn east. Go east eleven miles to a "T" intersection and turn south. At that point, maps show the roads wandering northeast and southeast from the intersection. However, the road to the southeast may have been realigned.

The location of the Beaver Creek Post Office was three miles east and two miles south of the intersection. Driving south on the road, there is a long-distance and wide view across the broad valley of Beaver Creek (the stream). There is an apparently modern ranch complex out in the valley, but no obvious direct access to it and it is some distance north of the supposed location of Beaver Creek.

#### **BYERS**

The establishment in 1868 of Byers is attributed to Oliver P. Wiggins, a former scout. The settlement was originally named "Bijou," a reference to its location on West Bijou Creek. In 1870 the Kansas Pacific Railroad laid track through the area and Bijou became a station on the railroad.

In 1873 a post office opened, with Oliver P. Wiggins as the postmaster. One report claims that Mr. Wiggins helped William N. Byers produce the first edition of *The Rocky Mountain News* and named the post office in gratitude to Mr. Byers.

In addition to being editor of *The Rocky Mountain News*, William Byers was the general manager in Colorado for the National Land Company, the agency for the sale of Kansas Pacific and Denver Pacific railroad land. It seems more logical that Byers himself was responsible for the naming of the post office.

May 2, 1889 John Fetzer and L. McDonner filed a town plat for Byers.

#### **BYERS - Continued**

As a station on the railroad, Byers served surrounding ranches and farms as a shipping point and a source of supplies. It continues to serve that function in addition to providing services to travelers on US Highways 40 and 287 and now Interstate 70.

Byers is a small community with some small businesses and a slowly growing residential population. At present, some thirty-five miles east of Denver at Exit 316 from I-70, it is on the margins of the metropolitan growth.

Sometime between my visits in 1990 and 1996 the post office moved from a small brick building in the town to a larger, more modern building just south of the exit from the Interstate.





# **CARY**

Cary was a ranch post office that operated briefly on Coal Creek east of Denver. I have found no information about Cary in the Colorado historical references I have studied. The Post Office Department records permit me to assign it a location, but provide no clue as to the source of the name.

The location of Cary, east of the rapidly expanding Denver Metroplex, gives me caution in providing directions to the site as roads in the area can rapidly appear or disappear as development progresses eastward from Denver and Aurora.

From Interstate 225, on the east side of Aurora, exit on to East 6<sup>th</sup> Avenue (Colorado Highway 30) and go east. Highway 30 passes north of Buckley Field and then turns southeast along Sand Creek. Continue south to East Quincy Avenue and turn east. The site of Cary was on the north side of East Quincy Avenue, five miles east of Highway 30 within, what at one time and perhaps still is, a military reservation.

In 1998 there was a large cluster of trees that obviously had been planted to serve as a windbreak, but there are no remaining structures.

# **CHERRELYN**

Cherrelyn was one of the southern suburbs of Denver. It occupied an area east of the South Platte River and along Santa Fe Drive and South Broadway. Eventually it was incorporated into the larger suburb of Englewood.

The Post Office Department Geographic Site Location Report indicates that the suggested name for the office was "Breene." That suggestion was rejected and the office became Cherrelyn.

The area that comprised Cherrelyn was and still is a mixture of commercial, industrial and residential sections. The industrial section is generally along the river and the railroads. The commercial sections are along Santa Fe Drive and South Broadway. The residential section is largely to the east of South Broadway.

From 1894 to 1916 the Cherrelyn Post Office operated as an independent post office. In 1916 the post office was closed but was replaced by Station Number 41 of Denver. This seems somewhat unusual, as Cherrelyn was not within the boundaries of the City and County of Denver.

#### **CHERRELYN - Continued**

The location of Station Number 41, at 4297 South Broadway is in close agreement with the location of the independent Cherrelyn Post Office. This would be on the northwest corner of the intersection of South Broadway and Quincy Avenue. That area is commercial and has undergone repeated redevelopment as businesses have changed or grown in size.

Although there is no longer a Cherrelyn Post Office the name has continued to be used by residents to designate their section of the city of Englewood.



# **CHERRY CREEK**

This place was originally called Twelve-Mile House, so known for its location on the Smoky Hill Stage Road, twelve miles from Denver. John G. Melvin came to Colorado in July 1859. In 1864 he purchased the 320-acre Twelve Mile Ranch on Cherry Creek and developed a saloon and inn that became a popular stop on the stagecoach route.

In 1881 the Denver and New Orleans Railroad began construction and by November the tracks had reached the vicinity of Twelve Mile House. From then on the history of Cherry Creek and Twelve Mile House become involved with the railroad, the railroad station and the subsequent post office named Melvin. Please refer to the discussion of Melvin for a description of this relationship.

The Twelve Mile House and Cherry Creek were on the east side of the stream of that name. The two sites of the Cherry Creek Post Office are now within the basin of the Cherry Creek Reservoir.

From the location of Melvin, continue east a short distance on Belleview Avenue to Jordan Road which turns to the southeast. The sites of the Cherry Creek Post Office would be about a mile and a half from Belleview Avenue and to the east of Jordan Road. Because they are within the reservoir basin, no structures remain. In 1998, Jordan Road was blocked and we could not continue south around the end of the reservoir and east to Parker Road. It is possible that something is visible from the south or the east.

It should be noted that the Post Office Department records are unclear as to the end of activity at the Cherry Creek Post Office.

# **DEER TRAIL / DEERTRAIL**

Deer Trail is another town whose origin is attributed to the "frontier scout" Oliver P. Wiggins. He is claimed to also be the founder of Byers in Arapahoe County and of Wiggins in Morgan County. He must have been a busy man who found it hard to settle down in one place.

It is claimed that Oliver Wiggins named the settlement for the deer that came to drink from East Bijou Creek.

#### **DEER TRAIL - Continued**

Deer Trail is located on East Bijou Creek. It was established when the Kansas Pacific Railroad built through the area on the way to Denver. There is some evidence that there was a settlement there prior to the arrival of the railroad as it was on the cattle trail from Texas to Wyoming and Montana.

Deer Trail claims to have been the site of the World's First Rodeo, held July 4, 1869. That event supports the existence of Deer Trail prior to the arrival of the railroad.

On November 29, 1875 the Kansas Pacific Railroad filed a plat for the town of Deer Trail.

Deer Trail did develop into a small town with a modest business district and a residential section. It was a shipping point for livestock and grain from surrounding ranches and farms. It still serves those purposes although the business district has diminished in size.

During the Cold War period of the mid twentieth century Deer Trail enjoyed a boom period as it became the residence and supply point for the U. S. Army Corps of Engineers, the Martin-Marietta Company and dozens of sub-contractors who were engaged in constructing the Titan Intercontinental Missile complex that spread out over the prairie northeast of Deer Trail.

Exit 328 from Interstate 70 gives access to Deer Trail.









# **ENGLEWOOD**

Englewood is another of the major suburbs to the south of Denver. The early history is a bit sketchy and there are contradictions in what has been written.

It is claimed that Thomas Skerritt and others first settled the area in 1859. No specific community name is attached to that reference. Another reference places the establishment in 1875 and states that it was originally a "pleasure resort" owned by A. C. Fisk and was known as Fisk's Gardens. Later it became known as Orchard Place for a large apple orchard.

There is a claim that the name "Englewood" first appeared in 1887 when, on June 27, D. G. Peabody and W. McGavock filed a town plat for Englewood. Others, who state that the name Orchard Place was changed to Englewood when the community was incorporated on May 13, 1903, contradict this claim. This later date seems the more reliable for the appearance of Englewood. That is also the date given for the consolidation of Cherrelyn with Orchard Place to create Englewood. The Cherrelyn Post Office continued independent operation for another sixteen years.

The name "Englewood" is from old English words "wood ingle," a wooded nook of corner. It may be connected to Englewood, Illinois, which was supposedly the hometown of one of the aldermen of the new city.

Englewood has become a major city, separating Denver on the north from Littleton on the south. It includes industrial districts on the western edge, a commercial district along Santa Fe Drive and a residential district that spans South Broadway.

The Englewood Post Office began as an independent post office, but in November 1913 it was converted to a Branch of Denver. In 1930, Englewood was restored to independent status.

Through its history, the Englewood Post Office has been consistently located on South Broadway:

# **FORT LOGAN**


In 1887, largely through the efforts of Henry R. Wolcott, an act of Congress was approved February 27, 1887, establishing a military post at Denver. The argument for the post was that it would be located at a major rail center, which would facilitate movement of troops to wherever in the west they might be needed.

The first troops arrived on October 22, 1887 and were quartered on property belonging to a Mr. Howard. On October 25 Major K. Brady of the 18<sup>th</sup> Regiment arrived in Denver from Fort Crawford. After assuming command he moved the troops to the military reservation, therefore the history of the military post officially dates from October 26, 1887.

Lieutenant General Philip Sheridan selected the site and at first the post was called "Fort Sheridan." When the War Department considered the official names for several new posts, General Sheridan asked that his name be given to a fort on the shore of Lake Michigan. That post had been designated to be named Fort Logan in honor of Major General John Alexander Logan, a Civil War military leader and Illinois politician. Conceding to Sheridan's wishes, the names of the two forts were switched and on April 5, 1889 and Colorado was officially home to Fort Logan.

Through the years, Fort Logan served the U. S. Army well. It was directed more towards advanced training than to basic combat training. During World War II, that effort fell to the new Camp (Fort) Carson near Colorado Springs. In 1941 Fort Logan became a sub-post of Lowry Field. On 1946 Fort Logan closed as a Military Post. Te Veterans Administration reactivated the hospital units at Fort Logan and used the facilities until they were moved to the new Denver Hospital in 1951.

In 1960, the portion of the reservation that included the post buildings, 308 acres, was transferred to the State of Colorado. The site has operated as the Fort Logan Military Health Center and also serves other state agencies. The remaining portion of the military reservation was retained by the federal government and is largely used as a cemetery.

#### **FORT LOGAN - Continued**

The Fort Logan complex lies on the boundary between Denver and Arapahoe counties. The Fort Logan Post Office appears to have at first been within the boundaries of the military reservation. The original Post Office Department Geographic Site Location Report is not definitive. The boundaries described in that report appear to be the boundaries of the military reservation and not a specific location for the post office.

The 1914 Site Location Report is definitive. That report and subsequent reports place the Fort Logan Post Office outside the boundaries of the reservation and at locations in Arapahoe County. These locations were on the east side of Lowell Avenue, south of Kenyon Avenue.

In 1971, the Fort Logan Post Office was converted to a Branch of Denver. Its final location was at 3818 Lowell Avenue.





# **JEFFERSON**

In the Post Office Department Records of Postmaster Appointments this post office is listed first under Kansas Territory and then under Arapahoe County. I now have found no reason to believe that it was within the boundaries of Arapahoe County as established by the Territorial Legislature in November 1861.

Prior to the creation of Colorado Territory in February 1861, a large portion of what became Colorado was designated as Arapahoe County of Kansas Territory. The western boundary of this county was poorly defined. Jefferson was the original name for Morrison in Jefferson County and there was a post office there from 1872 until the name change in 1873. Before then (1861-1863) there was a Jefferson Post Office in Park County. That office was reestablished in 1875 and continues to operate as a Community Post Office of Fairplay.

If forced to make a decision, I would assign the 1860 version of Jefferson to the location in Jefferson County that is now Morrison.

### LITTLETON

Littleton is the largest of the Denver suburbs in Arapahoe County. Denver was the county seat for the original Arapahoe County. In 1901, the Colorado Legislature created the City and County of Denver and Littleton became the county seat of the reduced Arapahoe County. It has maintained that honor to the present day.

Richard L. Little, a civil engineer from New England, took up a land claim in 1860 and in 1862 filed a homestead on the land that would eventually become Littleton. Little was instrumental in the formation of the Capitol Hydraulic Company and he surveyed an irrigation and water supply ditch across

his land. Water from the ditch powered the Rough and Ready Flour Mills which Little, with J. C. Lilley, owned and operated. In 1869 Little petitioned for a post office which was granted with the appropriate name of Littleton. Richard L. Little was the first postmaster.

Over the years Richard Little was instrumental in building the first store, a hotel, a church and schools in Littleton. In 1873 he was elected to the Territorial Legislature where he was a strong proponent of legislation to regulate irrigation.

The town of Littleton was platted in 1872 and it was incorporated on March 13, 1890.

For much of its existence Littleton was a rural community with an economy based on farming and supplying produce to the growing city of Denver. Soon after the end of World War II Littleton began to change. With the influx of people returning to Colorado after having spent time there during the war and with the expanding energy industry Littleton has grown rapidly. The Martin-Marietta Company plant, in the foothills southwest of Littleton, also brought a flood of new residents. By the end of the twentieth century, Littleton had grown into a major city on its own rights.

In the present day, Littleton continues to grow and to expand and is now a principal segment in the continuous Denver Metroplex that stretches south through Arapahoe county and on into Douglas County.

The Littleton Post Office has had a rocky existence. From its establishment in 1869 the Littleton Post Office moved frequently, most often to the business establishment of the then current postmaster. In 1939, at a cost of \$59,000 a new "permanent" post office building was constructed. As late as 1997 the Littleton Post Office was on the west side of South Prince Street, south of Alamo Avenue.

In 1902, Postmaster Maud Olmstead was accused of opening mail. Apparently the charges were not proved as she continued as postmaster until 1906.

On January 8, 1908 an unknown number of thieves broke into the post office and blew open the post office safe. \$300 and a number of stamps were stolen. At that time, the post office was in the Coors Building on the northeast corner of Nevada Street and Main Street, east of South Santa Fe Drive.





### **MELVIN**

This place was originally associated with the Twelve-Mile House, so known for its location on the Smoky Hill Stage Road, twelve miles from Denver. John G. Melvin came to Colorado in July 1859. In 1864 he purchased the 320-acre Twelve Mile Ranch on Cherry Creek and developed a saloon and inn that became a popular stop on the stagecoach route.

#### **MELVIN - Continued**

Historical accounts attribute John Melvin to having served as postmaster for as many as twenty-five years. They also make the claim that the post office was in his saloon so that John Melvin could attend to his duties as both saloonkeeper and postmaster. These claims are somewhat at odds with the records of the Post Office Department.

Between 1869 and 1895 there were two post offices in the vicinity of the Twelve Mile House: Cherry Creek (1869-1886) and Melvin (1888-1895). John Melvin did serve as postmaster at both Cherry Creek and Melvin, but he was not the only postmaster for the two offices. From the records, he served three separate appointments, totaling about twelve years.

In 1881 the Denver and New Orleans Railroad began construction south from Denver. On November 17 tracklaying for the railroad reached the future location of Melvin and the vicinity of Twelve Mile House. At the time, the post office (Cherry Creek) was at Twelve Mile House, about a mile and three-quarters east-southeast of the site of Melvin. Cherry Creek was on the eastern side of the creek of that name. Melvin and the railroad were on the western side of the stream. Eventually the activity at Melvin, which had a railroad station, dominated the area. The Cherry Creek Post Office closed in 1886. When a new post office opened in 1888, it was at Melvin.

Beginning at Exit 199 on Interstate 25, drive east on Belleview Avenue to where the hike and bike trail in Cherry Creek Reservoir crosses Belleview Avenue. This is also the vicinity of the intersection with a south extension of Peoria Street. The site of Melvin was in the southeast quadrant of this intersection. The location is within the waterline of the Cherry Creek Reservoir and only some scattered fragments of concrete foundations remain.

Continue east on Belleview Avenue to Jordan Road and then southeast towards the site of the Cherry Creek Post Office.

#### **PEORIA**

Peoria was a railroad post office on the Union Pacific Railroad, approximately midway between Deer Trail and Byers. It seems likely that there was a small community gathered around the railroad station and a siding from which livestock and produce were shipped.

#### **PEORIA - Continued**

The Kansas Pacific Railroad built through the area in 1870 but it was not until after the turn of the century that a post office was established. The post office lasted for eight years and it is probable that the need for the office faded as the Rural Free Delivery System expanded.

It is believed that the settlement was named after Peoria, Illinois.

The site of Peoria is on the southwest side of Interstate 70 at Exit 322 on the northeast side of the railroad. Anything that might have remained has been obliterated by the construction of Interstate 70 and Exit 322. This location is near the large dog-racing track that has not been in operation for several years.

### PETERSBURGH / PETERSBURG

Petersburg was a community south of Denver. It was set along Santa Fe Drive in the area that is now the western portion of Englewood. One version places it between Hampden Avenue and Oxford Avenue and another version expands the extent to be from Yale Avenue to Belleview Avenue.

Peter Magnes, of Swedish ancestry, came to Colorado in 1859. He was involved in several agricultural pursuits. The first was the planting of sugar beets, which has led some to call him the "father of the beet sugar industry in Colorado." In 1874 he built the Harvest Queen Flour Mill, which was a feature of the community until well into the twentieth century.

The name of the town reflects Peter Magnes' first name. At some time in the early 1880's the "h" was dropped from the end of the name. This is evidenced by postmarks but does not appear to have been an official action of the Post Office Department.

Peter Magnes filed the town plat for Petersburgh on September 20, 1873. As the town grew, it gained a rather unsavory reputation. Located beyond the city limits of Denver it became home to a large roadside inn, Wyman's, which was one of a row of roadhouses. Gambling flourished and there was other entertainment available for a price.

During the first decades of the twentieth century this was a source of constant friction with the police. In 1916, Petersburg was dealt a fatal blow - prohibition came to Colorado. It was the end of an era and Petersburgh settled back towards its agricultural roots and to a slowly developing industrial zone along the Denver and Rio Grande Railroad and the Santa Fe Railroad.

The Post Office Department Geographical Site Location Reports place the Petersburgh Post Office in the vicinity of the present day intersection of Hampden Avenue and Santa Fe Drive. The surrounding area is light industrial and it is questionable that any of the structures date from the nineteenth century.



Salem is described as a rural post office, seven miles southeast of Watkins. The description as a rural post office is apt, as when I visited the area in 1998 the countryside was wide open rangeland with very widely scattered farms or ranches.

Salem appears to have been a second attempt to establish a post office in this sparsely populated portion of Arapahoe County. It was preceded by the Cary Post Office (1888-1890), which had been located about two miles southeast of Salem. Salem did survive for almost twenty-five years.

#### **SALEM - Continued**

I have found no information as to the source of the name.

From the site of Cary, on East Quincy Avenue, drive one mile further east to Watkins Road. Turn north two miles to Yale Avenue. Turn west three miles to a road that angles to the northwest along the east side of Coal Creek. Salem was located south of Yale Avenue near the bend in the road.

In 1998 there were no remaining structures, but there were a couple of places that showed evidence of previous activity. From the site of Salem, continue northwest to Jewel Avenue and then west to Colorado Highway 30 (Gun Club Road).



### **TABOR**

The location of the Tabor Post Office is a mystery and it is questionable that it was ever in operation. I have found no reference to it in the Colorado History literature that I have read.

There is no Geographic Site Location Report on file and even though Tabor supposedly operated from August 1888 to April 1890 it was not included in the 1889 *Postal Guide*. That combination of facts allows me to suspect that this post office was never in operation.

It seems obvious that the place was named for H. A. W. Tabor, the famous "Silver King." Could it have been some development in which he had an interest?

Do not confuse this "Tabor" with the Tabor Post Office that operated in Lake County from 1879 to 1881.

#### WINNVIEW

In the spring of 1932 a young couple, named Winn, opened a small general store on the south side of US Highway 36, two miles west of the Arapahoe-Washington county line. A post office was acquired in 1933.

Plainview was the name requested for the post office, but that could not be used, as there was an operating Plainview Post Office in Jefferson County. Instead, the name Winnview was chosen.

It may seem surprising that this store/post office opened in the midst of the Dust Bowl years and the Great Depression. However, the new post office was fifteen to twenty miles from any other post office so apparently there was some need for a store and for postal facilities.

Two miles west of the county line, in a shallow road cut, US 36 crests a hill. In 1991 Jim Ozment and I stopped at the location. We climbed up the road cut to the fence line at the top and found a recently plowed field. We noticed a small area that had not been plowed and upon closer examination found the remains of the foundation for a building - all that remained of Winnview. This is just east of the intersection of Winnview Road, from the north, with US 36.






